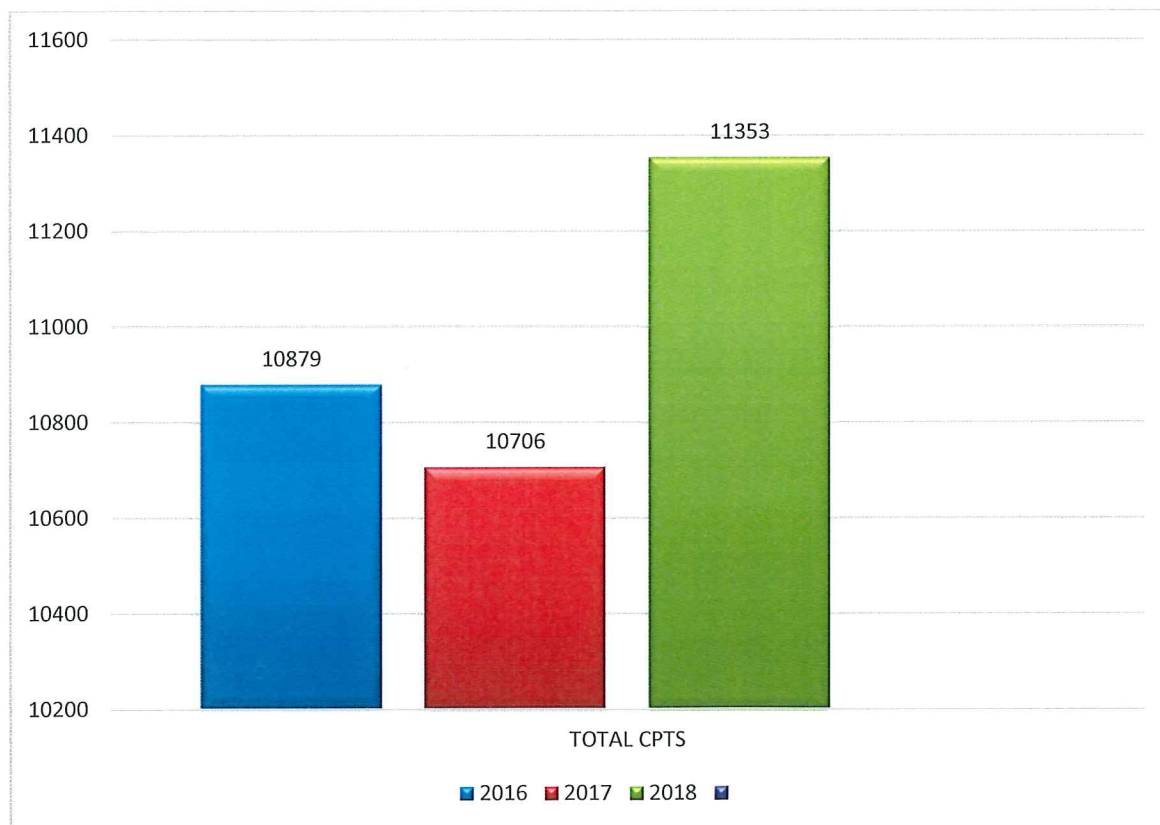

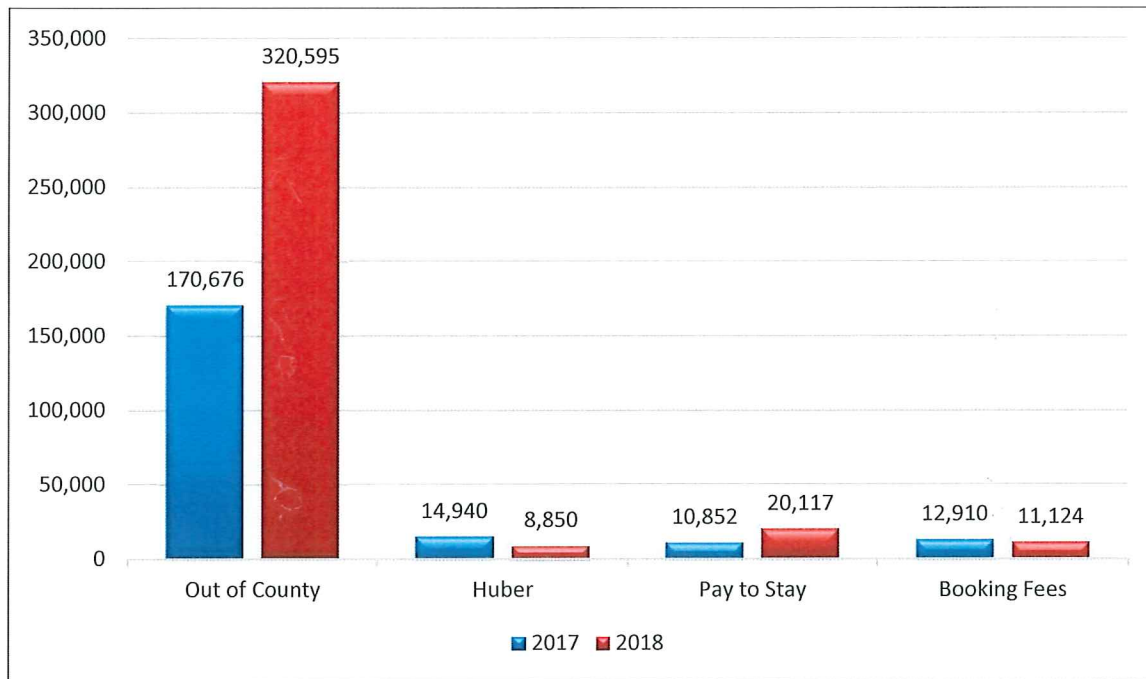

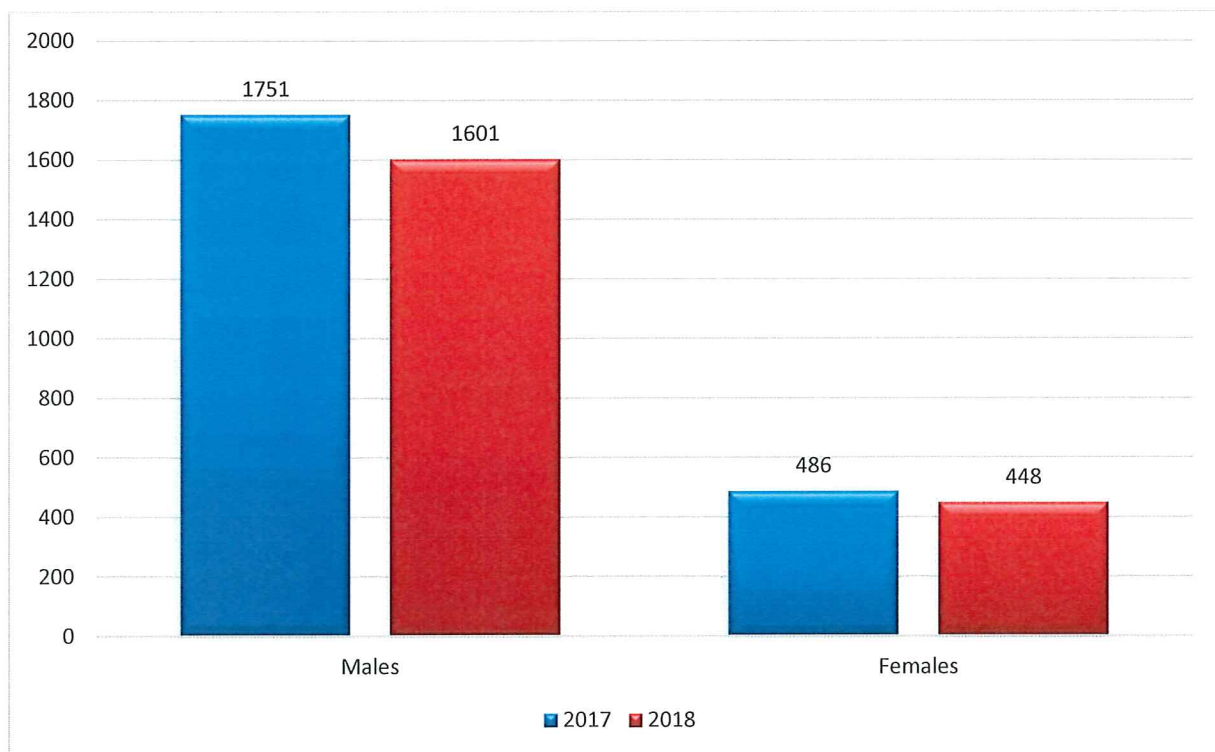

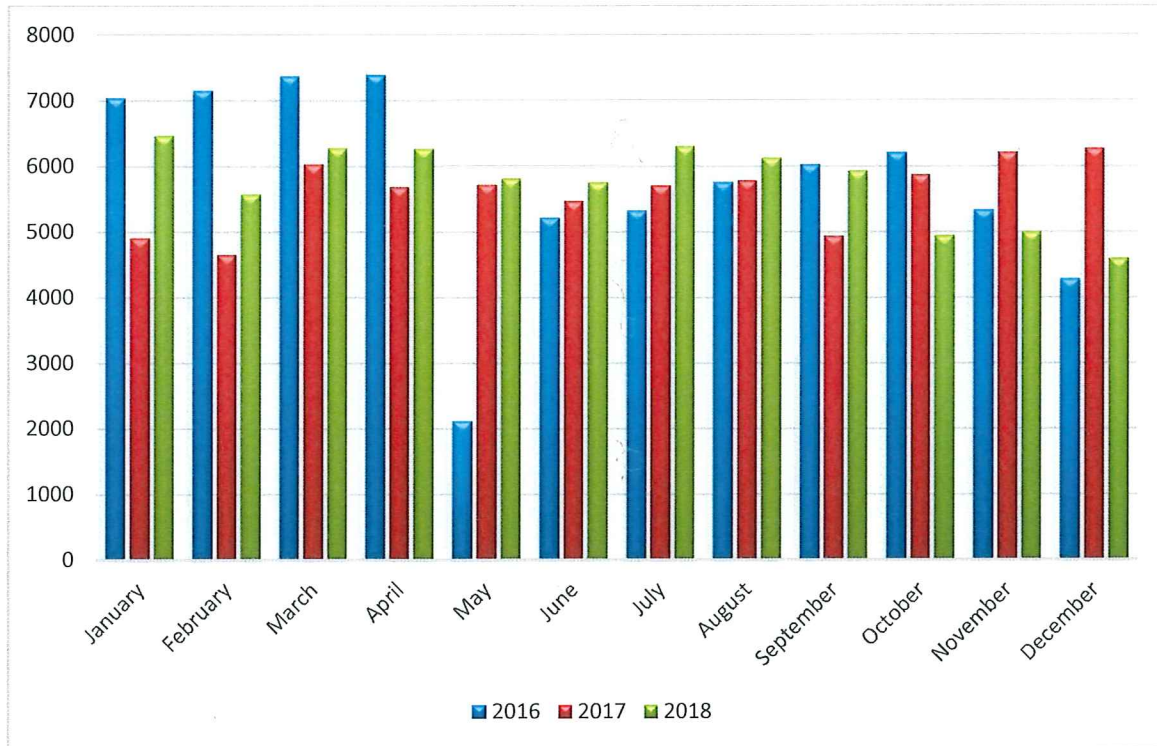
JAIL REVENUE 2018



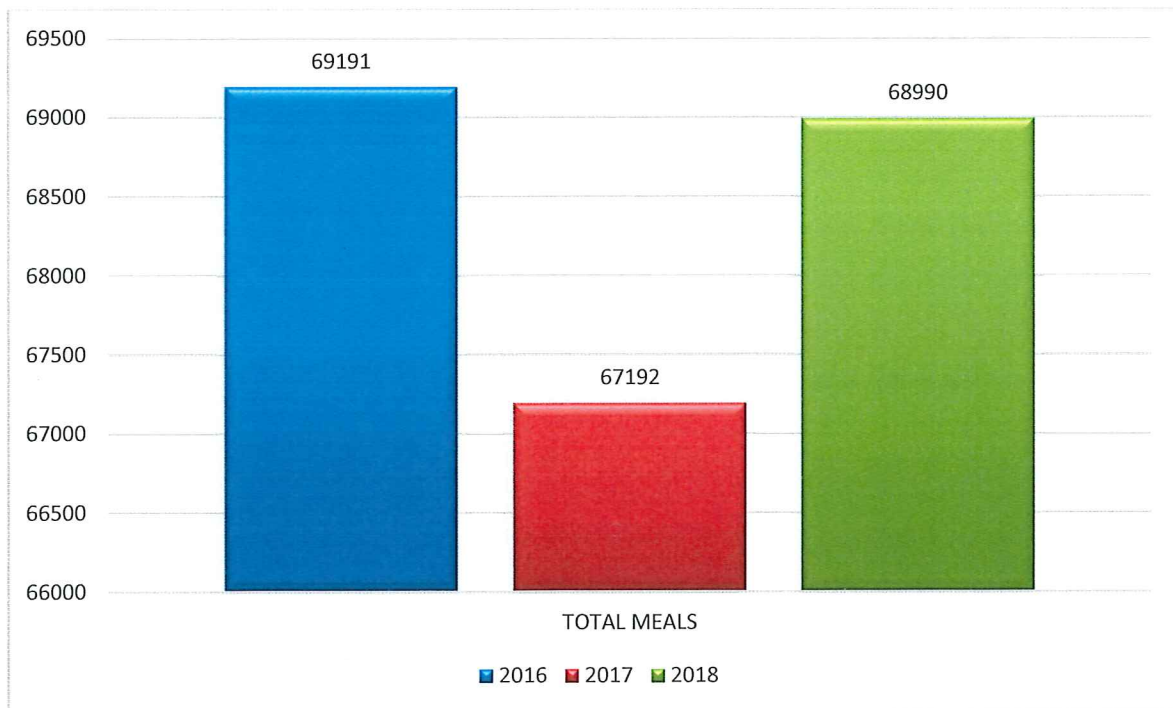
INMATE COUNT 2018
