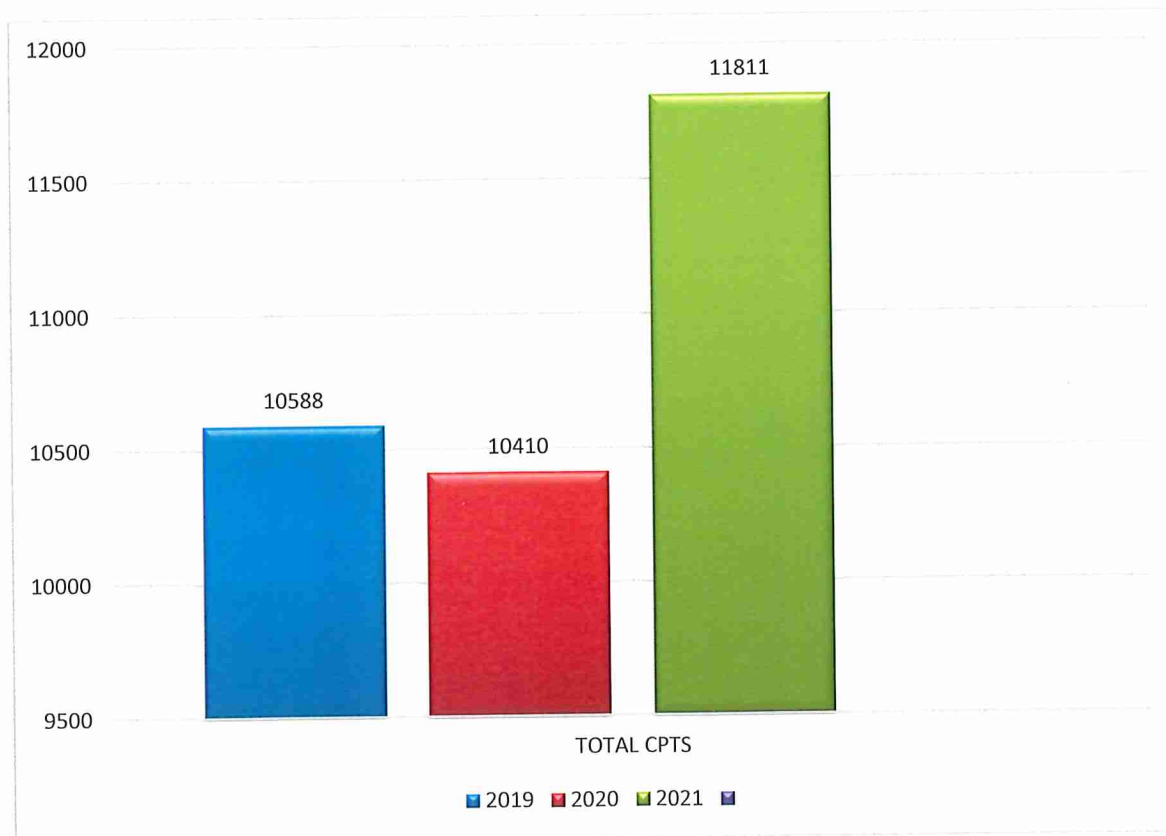

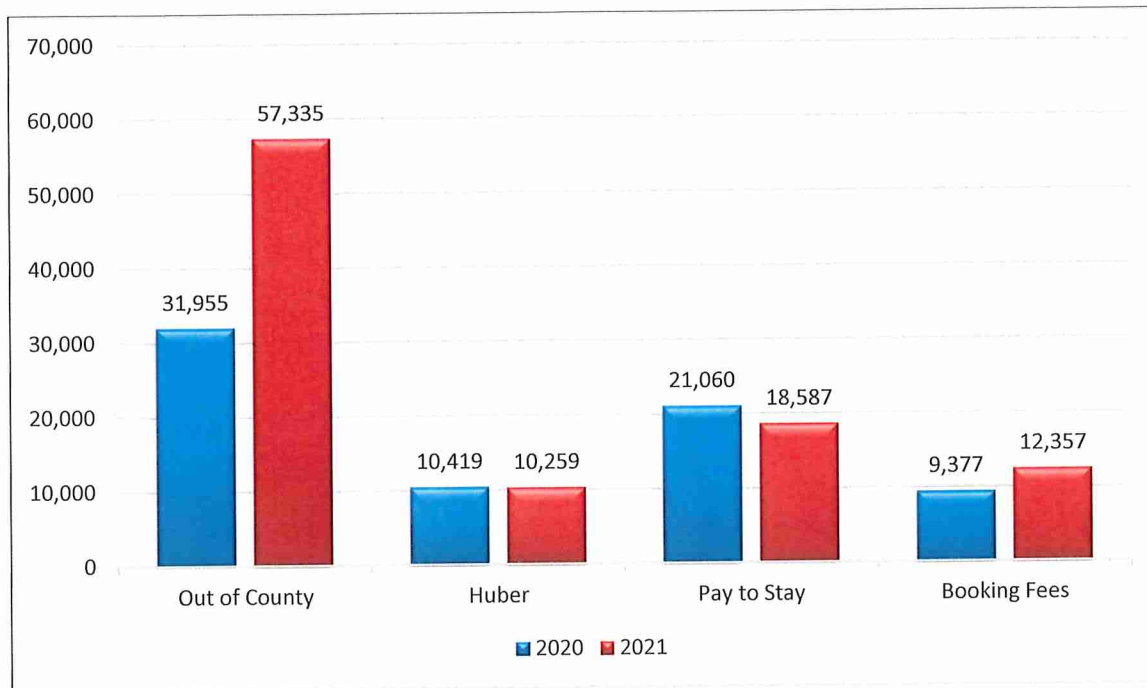

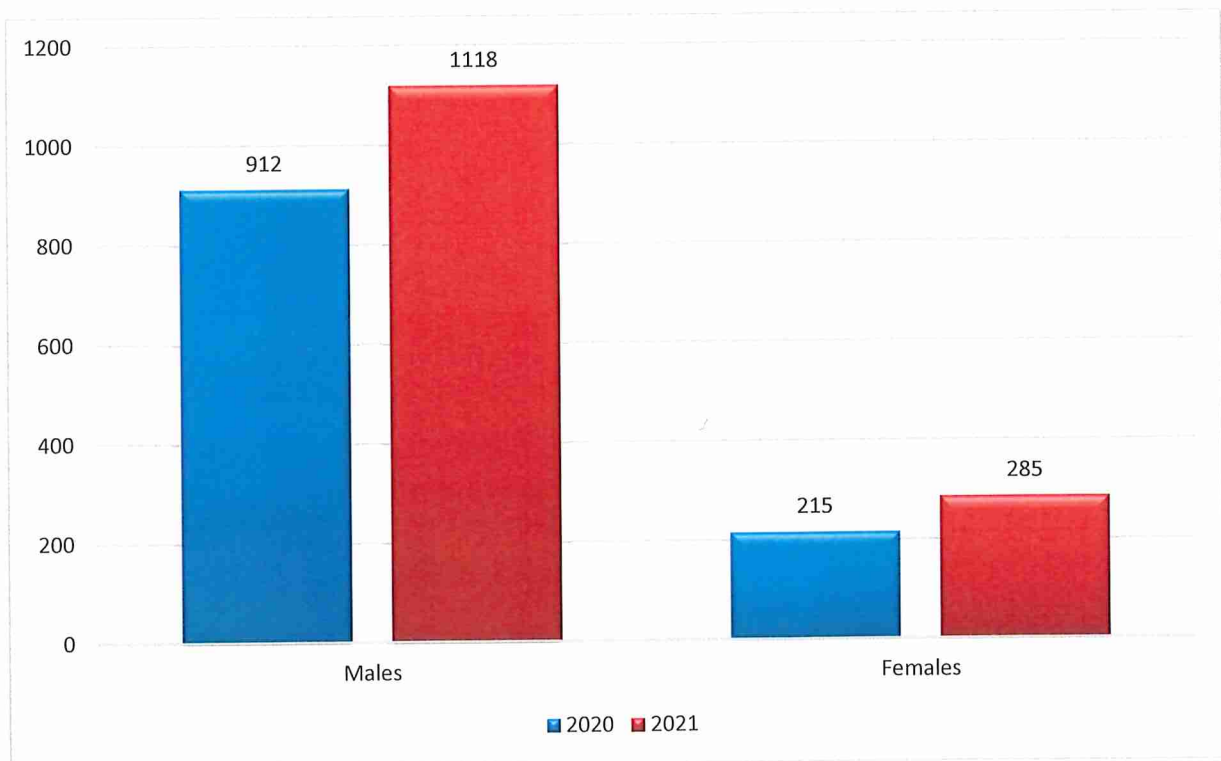

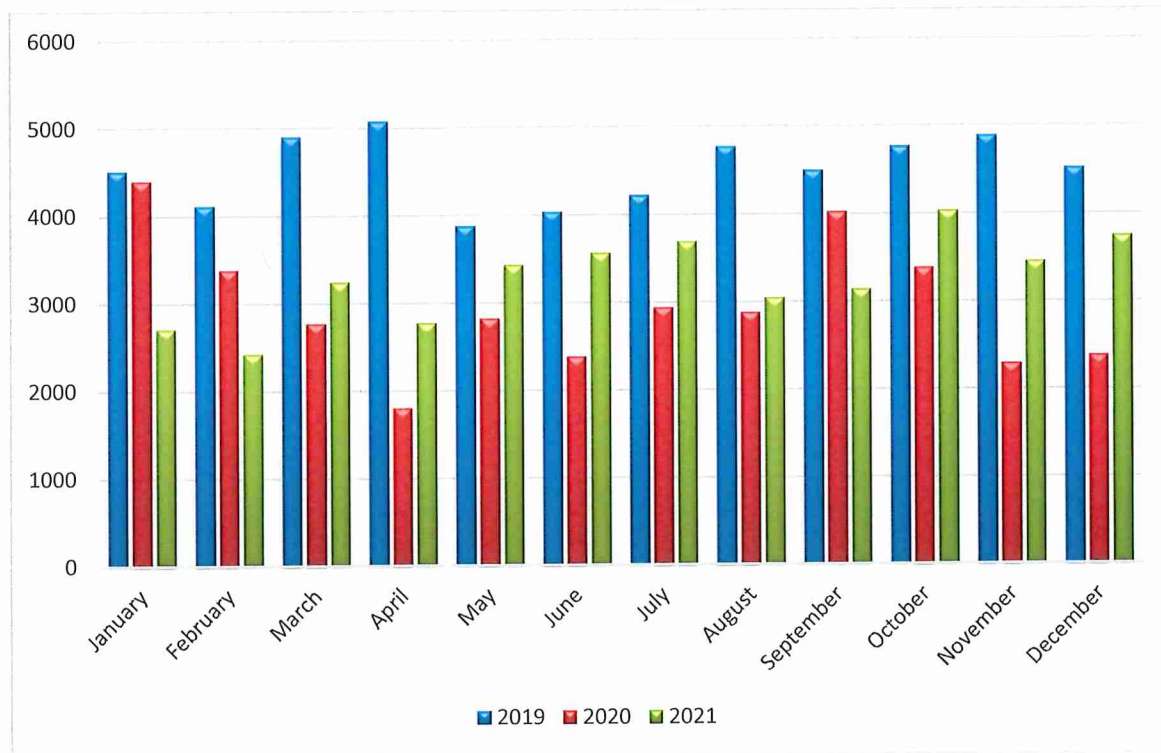
JAIL REVENUE 2021



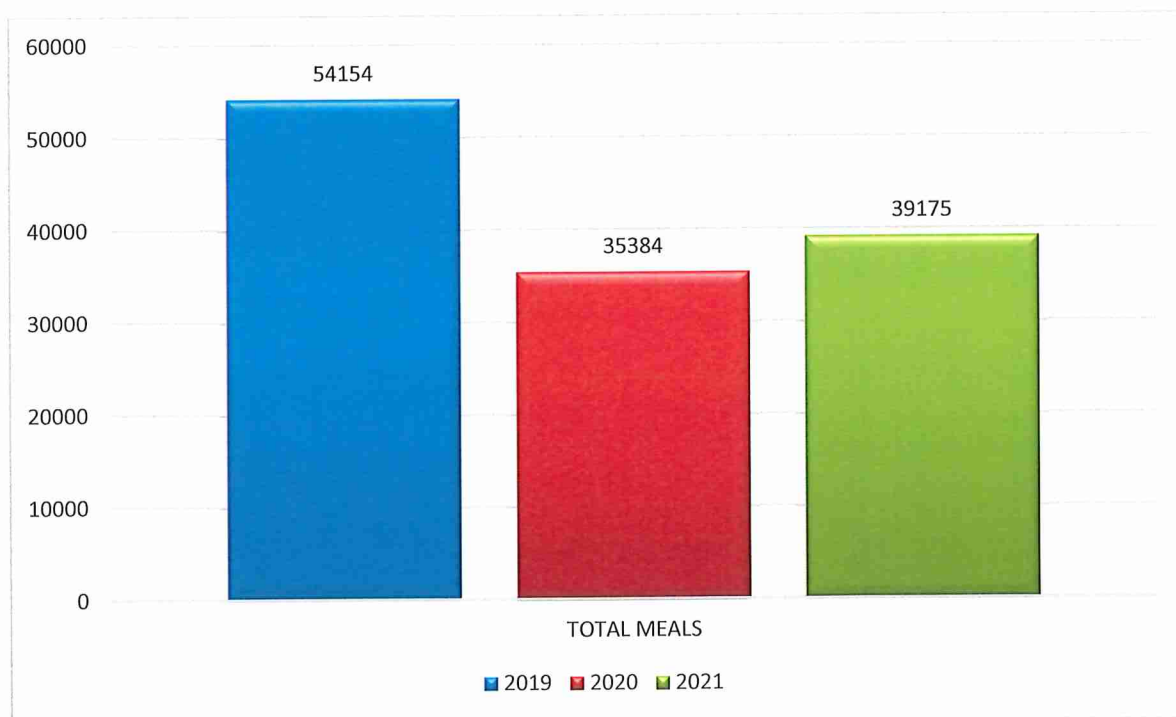
INMATE COUNT 2021
